A Word from the Director

My name is Misty Valenta and I am the new Williamson County Regional Animal Shelter Director. I am attempting to fill the very big shoes of my predecessor, Cheryl Schneider, who has retired and left us as stewards to the lifesaving legacy she created. Thank you to the staff, volunteers, and fosters who helped create a smooth transition so that our lifesaving never skipped a beat. You have been through so much this year – and you have outshined yourselves time and time again. I am incredibly lucky to be working alongside you.

This year has been extraordinary. The COVID-19 pandemic challenged our innovation. Not only to keep our cats and dogs safe – but our staff, volunteers, fosters, and community members safe. And even in these unprecedented times, you came through. Because of you, our shelter was the emptiest we have ever seen. On May 1st, we were housing 63 dogs and cats <u>combined!</u> The other 212 shelter animals were in your homes. You stepped up to foster most of our shelter animals and we could not be more grateful for your heartfelt support.

This year was also extraordinary because we challenged ourselves to do more for the most vulnerable animals at the shelter – dogs with training needs and young kittens.

Thanks to a generous gift from Maddie's Fund, we started a pilot program for dogs who needed training to help them get adopted. We called this program the Honor Roll because the behaviors that discourage adopters, such as barking or jumping in the kennel, are behaviors of smart dogs. These dogs are not "bad" - they are misunderstood and underserved. By bringing in a positive reinforcement-based trainer, their stay with us was enriched with personalized training sessions. 93% of these long stay dogs helped by the Honor Roll have already found homes.

The second pilot we started this year, thanks to the generous grant by the Orphan Kitten Club, is our Kitten Specialist position. Every year, our cat population explodes during the spring and summer months. Imagine taking in and caring for 1500 cats and kittens in only three months. This places an extreme stress on staff. And although our staff worked incredibly hard each and every year – the shelter could not raise our cat summer Save Rate. That is, until we started the Kitten Specialist pilot program. With someone solely looking out for the most vulnerable kittens,

our Save Rate rose from 89% last summer to an astounding 94% Save Rate this summer. Those little kittens survived and thrived because of our Kitten Specialist.

These two programs are shining examples of the hope and diligence the shelter possesses. Thank you for being a part of our lifesaving mission.

Saving Lives During a Pandemic

Nothing can stop the dedication the community has to saving the lives of dogs and cats in need – not even a pandemic. However, extra precaution was taken to keep everyone safe.

- Even though businesses began shutting down in late March and early April, the shelter remained operational with limited services throughout the pandemic.
- The shelter introduced protocols that all staff members, volunteers, and community members had to wear masks and physically distance apart from each other.
- The shelter continued adoptions and fostering to the community by appointment.
- With the assistance of the Williamson County IT Department, the shelter adopted a scheduling technology. Now, each potential adopter or foster has one-on-one attention with a staff member. This service has received compliments and will continue to be implemented going forward.
- Volunteers aided staff by taking on the roles of Matchmakers. These volunteers would communicate with potential adopters from the safety of their home working to help find a wonderful dog or cat match for each family.
- In order to decrease intake, the shelter began calling on community members to house found animals in their homes for 24 hours. These volunteer "reuniters" helped return dogs and cats faster to their families and lessened the number of animals in the shelter.

Volunteers

Volunteers are an essential piece of the shelter's lifesaving mission. They are a dedicated and hardworking extension of our staff. During FY 2019-2020, 231 new volunteers went through orientation. Over 7,826 hours were donated to helping each and every animal have the best life possible.









Shelfer Program Highlight:

Transport Program

The Transport Program started in January 2019 with only 12 dogs going to one partner in the northern United States.

In the 2019 – 2020 Fiscal Year, an astounding 383 dogs were sent to the Pacific Northwest. This increase was possible because of the support of our donors who value this all-donation-based program.

With the support of the community, we expanded from six rescue partners to eight. Not only did we expand our reach, but we also strengthened our existing relationships to expedite and reduce communications. The organizations now trust our assessment of the dogs in our care and we have learned what restrictions and preferences each organization has.

The shelter now consistently sends 25-30 dogs each trip and schedules one to two transports a month. Alexis Fine, Kennel Manager, has a goal to place longer stay dogs or dogs with special behavior needs onto transport. Most of our dogs entering this program, even the long stay or special needs dogs, are placed in adoptive homes within a couple of days.

The transport company meets at the shelter in the late evening to pick up the dogs and drive them up north. Dedicated staff members return to the shelter for these late-night meetings to ensure every dog is given a farewell and placed safely and securely in a crate for their journey. Each transport easily empties an entire room of dogs in the shelter.

The 10th Annual Fur Ball aimed to raise funds for our Transport Program and it exceeded all previous galas, bringing in over \$100,000. Because of the amazing support from the community, the shelter now transports 20 – 30 lucky dogs up north to partner organizations who do not have enough dogs to adopt out to families.

The Fur Ball had a star-studded crowd including KXAN Chief Weathercaster, Jim Spencer, Mud-puppies co-owner, Edward Flores, and their dog, Kaxan. Attendees were also able to meet and take photos with the shelter "spokes-dog" Champ, who had recovered from multiple severe injuries sustained from being drug behind a truck for a mile. Champ was then adopted by a Round Rock police officer who was drawn to his story and fundraised for his extensive medical care.
















- 4 1,674 dogs/puppies and 2,172 cats/kittens were spayed/neutered at the shelter before adoption.
- 391 cats/kittens were sterilized through our free-roaming spay/neuter clinic.
- 29 specialty surgeries were performed at the shelter.
- Average length of stay in the shelter for dogs was 12.0 days and 12.4 days in cats. (excludes time in foster homes)
